#### 4. TECHNICAL FEATURE

- **4.1** Construction: Should be Portable, Light Weight, Handy & Sturdy to work at rough & tough shop floor as well as on-board working condition.
  - 4.2 The machine should have the following in built feature:
    - i) HF Ignition Facility
    - ii) Pulse welding functions, slope up, slop down etc.
    - iii) Automatic gas Pre flow & post flow facility
    - iv) Gas test function
    - v) 2 Track/4 Track operation
    - vi) Over temperature protection
    - vii) Hot start/soft start
    - viii) Crater Fill current function
    - ix)Arc Force control
    - x) Anti-Stick
    - xi) Step less control of current settings.
- xii) Machine should measure the Resistance of the total welding circuit for every job thus resistance should not affect in the welding.
- xiii) Machine should measure the inductance of the total welding circuit for every job thus Inductance should not affect in the welding.
- xiv) in-built safety measures against open circuit, short circuit or phase fault etc.
- xv) The machine should have facility to store 0 to 999 numbers of welding parameters/job once established and activate these stored data during repetitive type welding.
  - xvi) The machine should have function selection: following processes:
    - a. DC TIG
    - b. AC TIG
    - c. DC Pulsed TIG
    - d. AC Pulsed TIG
    - e. TIG Tacking

- f. Spot Welding
- g. AC current offset
- h. Background current settings
- i. Duty cycle % settings main current and background current.
- xvii) The machine should be fully protected against overloading/prevent damage due to operations at higher current range than specified, through built in i tripping device.
- xviii) Machine should have provision to select the AC welding wave cycle in 'Sine, Triangle & Rectangular form in Aluminium welding.
- xix) Machine should have a function to make tungsten ball shape automatically (with diameter settings of the ball) for Aluminium welding.
- xx) The machine should have provision to change polarity of the Torch and earth cable by selection switch such that there is no need change the cables from the machine terminals.
- xxi) Machine should have provision to connect through 'WiFi.
- xxii) Should have USB port to connect Pen drive and extract saved welded Jobs in PDF, Also to connect (service dongles, licence keys, etc.) to update firmware.
- xxiii) Ignition timeout function and Arc break time (safety features while welding, the power source cuts our automatically.)

## **5.** Cooling Unit ( with IP 23 rating )

- i) Direct connection to the power source Plug and weld
- ii) should have AC pump with 600w cooling capacity at 1.01/min flow
- iii) should be Environment friendly cooling liquid (With safety data sheet)
- iv) should have Blow out mode to drain the coolant from torch body using existing protective gas.

#### 6: THE FRONT PANEL SHOULD HAVE THE FOLLOWING:

- i) Should have 4" or above colour text display with different language options, Welding voltage & current display
- ii) Operating mode.
- iii) Tungsten Size
- iv) Welding parameter values'like Gas.pre-flow and post flow time, down slope and up-slobe time, Pulse time, ignition current, main current etc.
- v) Set Values & Real Values of Welding parameters.
- vi) Over temperature indication.
- vii) Error display
- viii) Favorites button for quick access to the most important welding parameters.

ix) Display locking option with Key card reader for NFC keys (Contactless system)

## 7. Welding Torch

- i.Non-slip and soft components in the torch handle, with UP down buttons to adjust the welding current in Amps
- ii. Welding torch should have integrated LED light. Multilock torch body with adjustments.
- **8. Other accessories required**: Power Source, Cooling unit, 4m water Cooled TIG Torch, 4m long 35mm<sup>2</sup> Ground cable with clamp, Argon gas Regulator, Movable cart/ trolley with facility to hold the welding cylinder. Torch consumables for 1 month
- **9.** The equipment must comply with essential harmonized standards for health, safety, and environment and consumer protection. Machine should have with 'S' & 'CE' mark.
