## SECTION 1 A:- PROCEDURE FOR SUBMISSION OF E-TENDER

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates. - 3. Pressure range: Upto 29000 psi or 2000 bar.
- 4. The equipment should have high precision electronic digital pressure gauge with built-in pulsation damper
- 5. It should have the provision to operate **under batch mode and continuous mode**.
- 6. The Instrument should able to handle about 50 ml under batch mode
- 7. The Instrument should able to handle a maximum flow rate Flow rate **150ml/min** with a minimum process volume of **lesser or equal to 200 ml** under continuous mode.
- 8. It should have the manual pressure adjustment for a fixed flow rate.
- 9. **Pump type:** The equipment should have ceramic pumping piston equipped with specially designed packing that avoid the needs for lubrication water
- 10. Compression block should made of high-grade super duplex steel to ensure maximum stress resistance and reliability at high pressure.
- 11. The instrument should possess **touch screen control panel display**, pressure trend diagram display, built in safety protection against over pressure.
- 12. SS Feeding funnel at the inlet and Tri clamp connections at product inlet and outlet should be supplied.
- 13. **Homogenizing Valve:** The equipment should have an Impact head in ceramic and passage head made of tungsten carbide
- 14. The Equipment should have two homogenizing stages (first stage and second stage) and both of them should be arranged in series.
- 15. HEAT EXCHANGER should to be provided and it should be external at the outlet of the homogenizer
- 16. A set of extra spare part kit shall be supplied along with the machine.
- 17. Warranty: TWO YEARS
- 18. The CE certificate for the model of the instrument should be provided.
