## IMPORTANT NOTIFICATION

Sub: Prevailing condition arising out of the COVID-19 pandemic in the country - Revised notification issued.

Ref.: 1. Notification No. NITK/Admin-Estt./COVID-19/2020/B9, dated 14th March 2020.

2. Order No. సిఎఎల్.సిఆర్ 22/2020/88613/సి1, dated 17-03-2020 of the Deputy Commissioner & District Magistrate's Office, Dakshina Kannada District, Mangaluru.

This is regarding the prevailing condition arising out of the COVID-19 pandemic in the country and the advisory issued by the Government of Karnataka. The Institute has already issued advisory vide notification dated 14th March 2020 regarding the academic schedule as follows:

- 1. All Academic, Co-curricular and Extra-curricular activities in the Institute shall remain suspended with immediate effect till 31st March 2020 or until further orders.
- 2. The hostels shall remain closed with immediate effect and all students (UG, PG, and Ph.D.) except DASA, ICCR / MEA Students shall vacate the hostels and proceed to their homes on or before 17th March 2020 (Tuesday) without fail and wait for further instructions to return to the hostels. A separate notification will be issued for DASA, ICCR / MEA Students regarding their stay in the hostels.
- 3. All functions / programs and social / cultural gathering, etc., on the campus, shall remain suspended till 31st March 2020 or until further orders.
- 4. The students are instructed to visit the Institute website regularly for a revised academic calendar and other updates.
- 5. All employees of NITK are instructed not to travel abroad and/or entertain relatives / friends coming from Abroad to visit the campus till 31st March 2020 or until further orders.
- 6. All faculty, staff, and students are instructed to follow the advisory issued by the Ministry of Health and Family Welfare, Government of India, State Government and Local Authorities from time-to-time.

In continuation of the above notification dated 14th March 2020 issued by the Institute, Holidays are declared during 19-03-2020 to 31-03-2020 or until further orders, whichever is earlier. The residents of the campus and the faculty should stay home, avoid social gatherings and maintain social distancing to prevent the spread of the virus. However, all officers and staff in administration will continue to discharge their official functions over the internet/VPN and whenever there is a need to be physically present in the Institute, they would be required to do so. Officers and Staff should always be available on phone/email for contact at any point in time. All amenities, excluding the pharmacy, milk parlor and NITK Consumers' Co-op. Society will remain closed. All eateries except the Samudra Darshan Canteen will also remain closed during this period. The Health Care Centre, and essential services like Security, Housekeeping, etc., shall be functioning as usual.
