
I am directed to refer to this Ministry's letter F.No.34-9/2012-TS.III dated 8<sup>th</sup> April, 2013 on the subject mentioned above vide which the guidelines / criteria for implementation of HAG scales in respect of those Professors of NITs who are appointed as Directors in the National Institutes of Technology (NITs) system were communicated by the Ministry. Subsequently, the guidelines / criteria communicated on 8<sup>th</sup> April, 2013 was also reiterated in this Ministry's letter dated 23<sup>rd</sup> August, 2013 and further referred in communication of even number dated 15<sup>th</sup> January, 2014.

2. In partial modification of the letters dated 8<sup>th</sup> April, 2013 and 15<sup>th</sup> January, 2014, the undersigned is directed to communicate following modifications:-

"While implementing the HAG scales, those Professors of NITs and CFTIs who are appointed as Directors in the NITs system by the MHRD, shall deemed to have been placed in the HAG scale of Rs.67,000-Rs.79,000/- notionally from the day they took charge as Directors in NITs or from the day guidelines were issued by the Ministry vide its letter No.F.23-1/2008-TS.II dated 18<sup>th</sup> August, 2009, whichever is later."

"While implementing the HAG scales, those Professors of NITs who are appointed as Directors in the NITs system and other CFTIs by the MHRD,



shall deemed to have been placed in the pre-revised HAG scale of Rs.67,000-Rs.79,000/- notionally from the day they took charge as Directors in NITs and other CFTIs or from the day guidelines were issued by the Ministry vide its letter No.F.23-1/2008-TS.II dated 18<sup>th</sup> August, 2009, whichever is later."
