Provisional Result of Scrutiny of Applications for post of Students Activity and Sports Officer

With reference to the recruitment rules / criteria which is appended in this document, the provisional result of scrutiny of applications for the post of Students Activity and Sports Officer is published on the basis of the information submitted in the application and the supporting documentary evidence provided by the applicant.

The list of application numbers of the candidates who are eligible to participate in the presentation and interview process which will be held in the month of June – July 2025 is published herewith.

This provisional result of scrutiny of applications is subjected to the candidate fulfilling the following conditions:

- (1) The candidate has gone through the eligibility criteria published in the recruitment notification such as age, educational qualifications, experience, other requirements of statutory certificates and documents for the post applied by the candidate.
- (2) After ascertaining that the candidate is in possession of all original documents to which are required to establish meeting the eligibility criteria for the post applied by him /her, the candidate has submitted the application.
- (3) The candidate is aware that his/her participation in the recruitment process is subject to verification of all original documents by NITK authorities.
- (4) The candidate is aware that it is his/her responsibility to submit the required original documents to NITK authorities establishing his/her candidature meeting the eligibility criteria for the post.
- (5) The candidate is aware that, in the event of failure to establish his /her candidature meeting the eligibility criteria, his /her candidature will be cancelled by NITK authorities at any stage of recruitment process.
- (6) In such an event of cancellation of his/her candidature by NITK authorities for any reason, the candidate is aware that fees paid by the candidate will be forfeited and the candidate will not hold NITK liable from administrative, financial and legal matters in this regard.

- The candidate is required to make a 10-minute presentation (using maximum 8 slides) about their work experience, including a case study of relevant project or initiative.
- The presentation will be followed by a personal interview, and the performance of the candidate will be assessed comprehensively based on both presentation and interview.

History, Principles and foundation of Physical Education, Research Process in Physical Education and Sports Sciences, Principles and Methods of Sports Training, Tests, Measurement and Evaluation in Physical Education, Yogic Sciences, Sports Technology, Fitness, Wellness and Lifestyle Management, Applied Statistics in Physical Education and Sports, Physiology of Exercise, Sports Journalism and Mass Media, Sports Management, Sports Sponsorship, Contemporary trends in Physical Education and Sports, Olympic Movement.
